Action Note 2020/10/02: Changes to establishment listings for China

Purpose:

To inform Official Veterinarians of the changes to the format of unique identification codes of UK Approved Establishments for export of Products of Animal Origin.

These changes apply to beef, pork, dairy, fish products and live aquatic products exported to CHINA.

The date of change will be 1st OCTOBER 2020 for DAIRY (EHC 6288) and LIVE AQUATIC (EHC 7432 and EHC 7469) products only.

The dates of change for meat and fish products will be communicated later.

Background:

In the current context of the UK preparing to leave the EU, references to the "EC" need to be removed from exporting documents. These changes were implemented for all other countries maintaining approved lists in 2019.

Currently, the unique identification codes for UK establishments that are approved and listed for POAO exports to China are typically made up of either a "UK" prefix, a four digit unique approval code, and an "EC" suffix; for example, "UK 1234 EC" or a "UK" prefix, a two letter area code and three digit number forming a unique approval code, and an "EC" suffix, for example "UK AB 123 EC".

Changes will be made to these unique identification codes. An example is that "UK 1234 EC" would be changed to "1234". This will also apply to other formats of unique identification codes; for example, a code currently presented as "UK AB123 EC" will read as "AB123".

Consignments from approved establishments will therefore still be identifiable due to the continued use of their unique identifying codes in the entries of the relevant sections or export health certificates and marks applied to products.

Illustrative examples:

CURRENT format used for EHCs	New format to be used for EHCs
UK 2090 EC	2090
UK AB 123 EC	AB 123
UK CD 456 FE EC	CD 456 FE
UK CD 456 M EC	CD 456 M

A crossover period of 3 months from 1st October until 31st December will be applied, during which both formats will be accepted to allow for consignments in transit and any initial oversights

Procedure:

Certificates requiring entries for approval/registration numbers of establishments must be completed using the format of current or new listing details, as necessary at the time of certification.

The new listing will become in force as soon as the updated lists are published by China or at any time mutually agreed with China.

These changes are taking place regardless the outcome of the UK's exit from the EU. The aim is to future-proof the code by which UK establishments are listed by importing trading partners and for that code to cover and be applicable for any possible options of health/ID marking in future.

For animal product commodities to countries which do not require specific listing, where Export Health Certificates (EHCs) include entries for approval / registration numbers of UK establishments, such entries will also be made in the new format from 1st January 2021

Field Staff are required to:

Note the contents of the action note, OV certifiers to ensure that the Action note is read and understood.

Save the action note on their laptop for reference alongside a downloaded copy of the SMOC. Where necessary, print a copy for the plant file.

Operations admin are required to:

Upload to the Action Note Live Folder and Operation tracker log.

Forward to Website mailbox (website@fss.scot) for publication on the website in publications.

The action note will remain live until either incorporated in the SMOC, or revoked. Operations Admin will maintain copies of the live and revoked action notes. Comms will add a link to action notes in the relevant portion of the SMOC.
